CASE STUDY #1

30-year transfer agent client taps EQ for new equity plan solution



Situation

An existing 30-year client in the technology space needed a new flexible equity plan solution. The client wanted to transfer its plan over as a cash award and allow its employees to see the real-time market value of its stock on its dashboard.

The client was pleased with EQ's transfer agent services knowledge and experience. Because of its status as a trusted advisor, the client approached EQ for this new project.

Solution

EQ worked closely with the client's compensation team to understand their needs. Transfer agent and equity plan solutions (EPS) relationship managers collaborated and determined that the EQ EPS platform could convey the company's compensation awards as needed. The team proposed an employee equity plan set up as a restricted stock unit (RSU) that would be settled in cash which met the company's ask to transfer the plan over as a cash award. This also allowed the company's market stock price to be reflected in real-time on its dashboard to its participants.

Results

EQ's services beyond transfer agency tasks allowed it to be chosen as its client's new equity plan provider. Using a single provider created greater process efficiencies and cost savings for the client, boosting its overall satisfaction.

CASE STUDY #2

EQ's complex corporate actions expertise leads to a successful exchange offer

Situation

A long-standing multinational transfer agent client sought EQ's corporate actions knowledge and experience for a complex exchange offer involving more than 1,000 global shareholder entities, multiple classes of shares and a share value worth billions of dollars. This offer carried unique documentation requirements and had an intricate technical transaction process that required processing large volumes of transactions in a tight timeframe.

Solution

EQ's cross-functional team of experts included transfer agent and information agent teams as well as administrative teams in corporate actions, finance, technology, processing, correspondence and data. They collaborated to create a tailored online platform to simplify submission of required documentation as well as to provide necessary communications. The effort took months of strategic planning and the execution occurred over a four-week transaction period.

Two key elements of the solution were a secure, dedicated online platform and a robust call center. The online platform:

- Provided a secure, end-to-end conduit for shareholders to submit their required documentation and exchange elections.
- Saved time and maintained accuracy and efficiency.
- Eliminated the wait for physically mailed exchange offer letters of transmittal — with more than 200 million shares to be processed in a tight four-week window, this was critical.
- Communicated the details of the complex corporate action and gave explicit instructions on how shareholders could participate, which led to a high shareholder participation rate.

The call center agents were specifically trained and had access to multimedia resources and tools that provided thorough information to shareholders and addressed specific shareholder inquiries such as how to calculate conversion rates, whether there were any trade restrictions and what payment options were available.

The client also hosted a shareholder-facing conference call that included its EQ relationship manager, who addressed questions related to the exchange.

Results

EQ's relationship management team's industry experience, combined with the expertise of the corporate actions team and the execution of the transfer agent operations team, enabled EQ to seamlessly execute this complex transaction.


